Group Discussion Topic: Business ethics in the pharmaceutical industry

Personal Interview

P1: Tell me about yourself.

Me: Prepared answer, mentioned Chess as a hobby—P3 took note of that.

P2: So you work in EPFO, tell me what's the difference between PF and NPS. Which one is better?

Me: Explained basic differences. Mentioned that EPF has a fixed interest rate, while NPS is market-linked. Said that returns depend on market performance.

P2: How do you compare the old and new tax regimes? What about the lack of deductions in the new one?

Me: Explained that the government seems to prioritize keeping more money with individuals, leading to higher spending and economic growth. Mentioned the trade-off that people may invest less in long-term instruments.

P2: So you're saying people don't invest long-term if they have more money?

Me: Mentioned that it might reduce since financial literacy is not high, and the old tax regime's deductions encouraged long-term investments.

(P2 pointed out a contradiction, but seemed satisfied with my response.)

P3: You said India is doing great in chess recently. Why recently?

Me: Talked about the exceptional young talent emerging now.

P3: Yeah, but why only now? Chess was invented in India, and until recently, it was dominated by the Soviets...

Me: Mentioned Vishy Anand's impact as an inspirational figure and how India's economic growth now allows more people to take up sports.

P3: Then why aren't we winning at every sport?

Me: Talked about the lack of similar inspirational figures in other sports. Gave examples of the 1983 Cricket World Cup starting India's cricket boom and how Neeraj Chopra is inspiring more javelin throwers.

P3: Why should India prioritize sports with so many other issues?

Me: Had a discussion on the importance of sports. Justified that sports are also essential for national pride, youth engagement, and overall development. He seemed satisfied.

P3: What is the Elo rating?

Me: Said it's a formula I don't recall exactly, but it determines rating changes for chess players.

P3: Who's currently the highest-rated chess player from India?

Me: Arjun Erigaisi.

P1: You did Civil Engineering from IIT Kharagpur. Instead of continuing in that, you're going all over the place. Why?

Me: Explained my lack of passion for civil engineering and my inclination towards civil services from an early age.

P1: Then why did you do engineering?

Me: Said I liked Math and Physics and was good at them. \bigcirc The panel members smiled—at least, I think they did.

(P1 asked a few more questions around this before shifting to my software work experience.)

P1: Which programming language did you use? How is Ruby different from Python? Is Ruby on Rails still widely used?

Me: Answered. He seemed satisfied.

Duration: 15 minutes Experience: It felt like a conversational interview, mostly about my profile and interests. I didn't feel grilled.

GD Topic: Brands using influencer marketing (not exact wording) Groups of 5-6 were formed. 1-2 min to discuss and make up points. 10 min to discuss.

Personal Interview

M2: Yes sir, tell me about yourself.

Me: Told prepared answer.

M2: Tell me about your journey in stock markets (SM was my hobby).

Me: Explained.

M2: Which ratios do you use?

Me: Sir, I majorly use ratios like PE ratio... (Was cut in between)

M2: What is P/E ratio?

Me: Told.

M2: So let's say there's a company with P/E of 21. Is it overvalued or undervalued?

Me: Told that it depends on the sector and the growth prospects. Gave examples of a few where 21 is expensive and 21 is cheap. M2 looks satisfied.

M2: What is a unicorn?

Me: Told.

M1 (takes over): How many unicorns in India?

Me: Not sure.

M1: At least how many startups in India?

Me: Not sure.

M1: What is India's rank in the number of startups?

Me: Not sure, but can take a guess... 5?

M1: So what project did you do in your UG?

Me: Told the title (was a bit complex). Sir, let me explain... (was cut off)

M1: No no, that's okay. It will get too technical for me (with a smile). Was it a group or individual?

Me: Told.

M1: Tell me what do you do at your job? What projects are you working on now?

Me: Told in detail (looks satisfied).

Me: Told.

F1: Any special initiatives for women entrepreneurs?

Me: Not sure, mam.

M2: Crowdfunding vs T-Hub funding? Which is better?

Me: Told.

F1: What is insider trading?

Me: Told in detail.

F1: Can you give any recent examples of insider trading?

Me: Gave a recent example of the front running case involving Ketan Parekh. Briefly explained how it was carried out. (Was cut in between)

F1: Thank you, we're done.

Overall, it was a friendly interview lasting for 11-12 min. They informed us beforehand that they were going to go for a max of 15 min whatsoever.
